APPLICANTS FOR THE POSITION OF AUDITOR GENERAL

The President of the Republic of Kenya, and Commander-in-Chief of the Kenya Defence Forces, in compliance with Section 11(2) of the Public Audit Act, 2015, declared a vacancy in the position of the Auditor-General Vide Special Gazette Notice Vol. CXXI No. 111 of 27th August 2019, and invited applications from qualified persons for appointment to the Office. Pursuant to Section 11(5) of the Act, The President constituted a Selection Panel to consider the applications, and to select at least three persons qualified for appointment as Auditor-General. In total, this position attracted seventy candidates as follows:
